Neutral wire is required to power the device.


Working with mains electricity is extremely dangerous. If in doubt, contact an electriciar for installation.


The following instructions apply to standard light switches. For other instructions, please go to https://cloudfree.shop/start

1. Open the old switch and carefully pull it out of the wall. First, use a test pen to distinguish the live wire and the load wires and mark them with labels.

Then find the main switch for the device in the circuit breaker and turn it off. (After turning off the main power switch, please use a test pencil to reconfirm whether the power has been cut off).



2. After turning off the power, find the white wire and other wires that need to be installed in the box and mark them. Remove the old switch after marking. (If you cannot find the white wire, you cannot do the installation by yourself. In this case, you must consult a professional electrician).



Please remove the old switch after identifying the four wires, otherwise install the wires back to their original position or consult a professional

White represents the neutral line. Black represents the live/hot or load line. The green or a single bare copper wire represents the ground wire.



## 3. Connect the corresponding wire to the product with a wire nut:

Switch		connect with	Wall
green wi	ire –		ground line
white wi	re –		neutral line
black wi	re –		live/hot line
red wir	e –		load line.

Be sure to screw the device into the box and close it with a faceplate so that no one is inadvertently electrocuted.

After the installation is complete, turn on the circuit breaker. Now you can connect the device to your home network.
